The Service Director shall register and issue sticker registration tags to all firms or individuals who:

(a) Complete an application form prescribed by the Service Director for the registration of private snow removal firms and individuals; (Ord. 64-79. Passed 5-29-79.)

(b) Pay a registration fee of ten dollars (\$10.00) per year for each vehicle for which sticker registration tags are to be issued; (Ord. 97-94. Passed 9-26-94.)

(c) Demonstrate proof of liability insurance with limits in the amount of fifty thousand dollars (\$50,000) per person and one hundred thousand dollars (\$100,000) per occurrence for bodily injury and fifty thousand dollars (\$50,000) property damage liability. (Ord. 64-79. Passed 5-29-79.)
